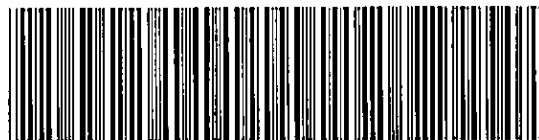

ARTICLE III

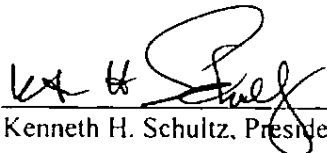

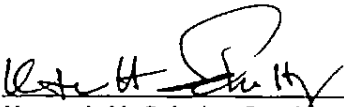
