**ARTICLES OF ORGANIZATION
FOR
S & T FINANCIAL, LLC**

ARTICLE 1 – Name. The name of the limited liability company shall be S & T Financial, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 3267 Student Way #28B, Orlando, Florida 32826.
