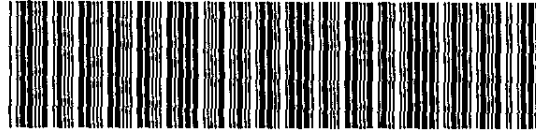

**ARTICLES OF ORGANIZATION
OF HARRY C. NEWSTREET AND ASSOCIATES, LLC.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I. - NAME

The name of the limited liability company will be:

Harry C. Newstreet and Associates, LLC.

ARTICLE II. - PRINCIPAL OFFICE

The principal office will be at 1000 South Federal Highway, Suite 202, Deerfield Beach, Florida 33441. The mailing address will be the same as the principal address.

ARTICLE III. - INITIAL REGISTERED AGENT AND STREET ADDRESS

A member may transfer his or her interest in the Company as set forth in the regulations of the Company, but this transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other member(s) of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE IX. - MANAGEMENT
