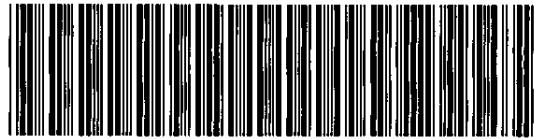

The mailing address and street address of the principal office of the Limited Liability Company is **10701 Lake Louisa Road, Clermont, FL 34711**.


Article III
