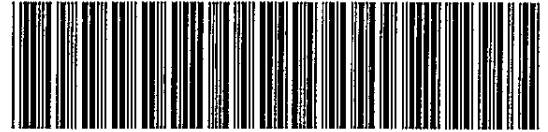



The right of the Members to admit additional Members and the terms and conditions of the admissions shall be specified in the Regulations.


ARTICLE VII - MEMBERS RIGHTS TO CONTINUE BUSINESS


