

ARTICLES OF ORGANIZATION OF

MAJCK, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be MAJCK, LLC ("company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 6649 CR 150 Wildwood, Fl 34785.

ARTICLE III -- DURATION
