**ARTICLES OF ORGANIZATION
OF

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

ARTICLE I

Name. The name of the limited liability company ("Company") is CORPORATE CUP CHALLENGE, L.L.C.

ARTICLE II

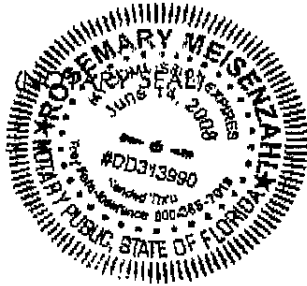
