ARTICLES OF ORGANIZATION OF BRADENTON BOAT CLUB, LLC, a Florida Limited Liability Company

The undersigned, being the authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

ARTICLE I

The name of the limited liability company shall be BRADENTON BOAT CLUB, LLC, a Florida limited liability company (the "Company").

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company of Street South, Suite 137, Naples, Florida 34102.

ARTICLE VI DURATION

The initial manager of the Company shall be Norman C. Burke, until his successor or substitute is appointed in accordance with the Operating Agreement and Regulations of the Company. The number of managers may be decreased or increased in accordance with the terms of the Operating Agreement and Regulations. The address of the initial manager is 568 9th Street South, Suite 137, Naples, FL 34102.
