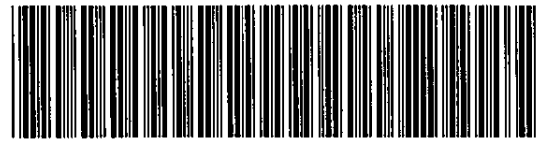

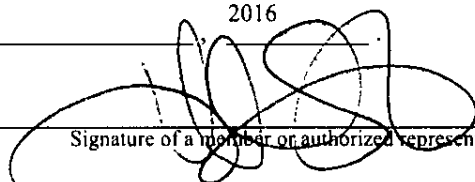

1. The name of the limited liability company is INLAND SEAS APARTMENTS, LLC (the "Company").

2. Article II of the Articles of Organization of the Company is amended to read as follows:

ARTICLE II. PURPOSE OF THE COMPANY.

The purpose of the Company shall be limited to owning, operating, managing and leasing the property commonly known as Inland Seas Apartments (the "Property") and activities incidental thereto. The Company shall be prohibited from incurring indebtedness of any kind except for the mortgage loan and other indebtedness (the "Indebtedness") incurred in favor of EverBank, a federal savings bank and its successors and or assigns as their interest may appear, with respect to the Indebtedness ("Lender") and trade payables incurred in the ordinary course of business.

3. This Amendment was recommended by the board of directors to the Company's members on January 12, 2015.

4. This Amendment was approved the Company's members entitled to vote on the Amendment, and the number of votes in favor of the Amendment was sufficient for approval.
