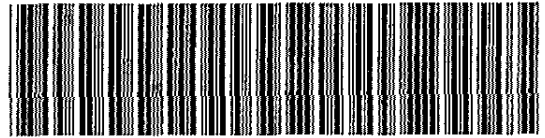

### Transfer of Member's Interest




