



ARTICLES OF ORGANIZATION FOR EQUINE LEGACY 2004, LLC A FLORIDA LIMITED LIABILITY COMPANY



ARTICLE I. NAME

The name of the Limited Liability Company is EQUINE LEGACY 2004, LLC" (the "Company").

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the Company is 2902 SE 14th St., Ocala, FL 34471.

ARTICLE III. DURATION

The period of duration for the Company shall be perpetual unless the Company is earlier dissolved in accordance with either the provisions of the *Florida Limited Liability Company Act*, Sections 608.401 through 608.514 of the *Florida Statutes Annotated* (the "Act") or the Company's Operating Agreement among the Members (the "Operating Agreement").

ARTICLE IV. MANAGEMENT

The Limited Liability Company is to be managed by a Manager or Managers. The names and addresses of the initial Managers of the Company are:

ARTICLE V. PURPOSE

The purpose for which the Company is being organized is to purchase, own and re-sell thoroughbred race horses, to be purchased as yearlings and re-sold either as two-years old in training or through other sales avenues, and to transact any other lawful business approved by the Members of the Company for which a limited liability company may be formed under the laws of the State of Florida.

ARTICLE VI. MEMBERS' RIGHTS TO CONTINUE BUSINESS

The right of the remaining Members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company shall be upon the consent of all of the remaining Members in accordance with the terms and conditions of the Operating Agreement, provided that there is at least one (1) remaining Member.

ARTICLE VII. AMENDMENTS

The Company reserves the right to amend, alter, change or repeal any provision contained in these Articles of Organization, in the manner now or hereafter prescribed by the Act.
