**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
ARQLINE, LLC**

Pursuant to Sections 608.411 of the Florida Limited Liability Company Act, the Articles of Organization of **ARQLINE, LLC** originally filed with the Secretary of State of the State of Florida on December 22, 2004, are hereby amended and restated in their entirety as follows:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is **FINELINE DESIGNS, LLC**

ARTICLE II — Address:

ARTICLE III — Registered Agent:
