**ARTICLES OF ORGANIZATION**

**ARTICLE IX - AMENDMENT**

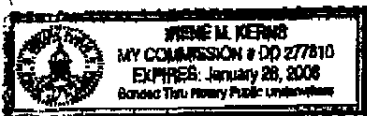
