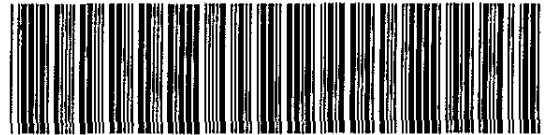




**ARTICLE VI - Admission of Additional Members:**
