ARTICLES OF ORGANIZATION OF
HOUGH & CROFT ELECTRIC, LLC

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act:

ARTICLE I

The name of the limited liability company is HOUGH & CROFT ELECTRIC, LLC.

The period of duration is 30 years from the date of filing by the Florida Department of State. This limited liability company shall become effective January 1, 2005.


