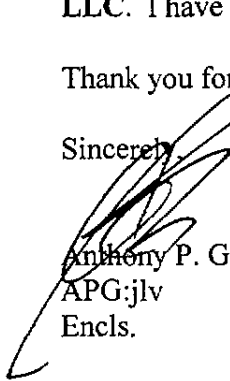

**ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY
COMPANY**

ARTICLE I

Name

Members

The right, if given, of the members to admit additional members shall be by decision of a the manager. The conditions of the admission shall be as determined by the manager. The manager is required to maintain a list of each member of the LLC. This membership list shall be available for inspection by all members of the LLC. Certificates of membership may be issued to each member representing that members' percentage of ownership interest in the LLC if agreed by a majority of the members.

ARTICLE VI I

Members Rights to Continue Business

2. If no existing member is willing to purchase the membership interest of the selling member, the selling member may then sell his or her membership interest to a non-member who is approved by the manager. Approval shall not be unreasonably withheld.

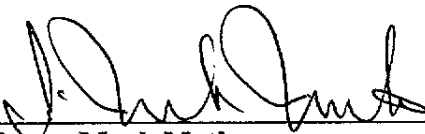
