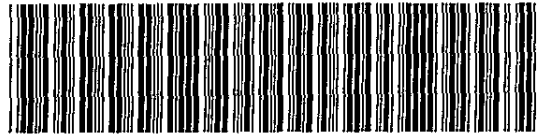

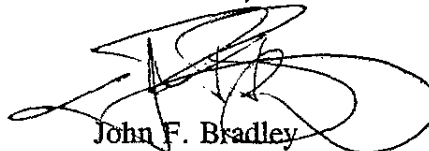

ARTICLE I: NAME

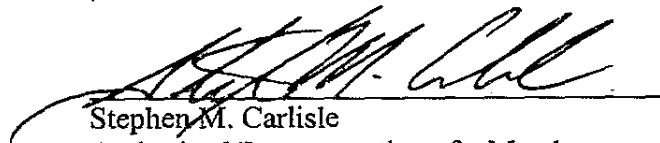
