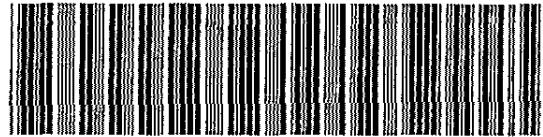

ARTICLE IX -- MEMBER RIGHT TO CONTINUE BUSINESS

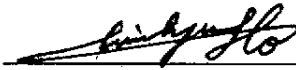
The company shall not be dissolved on the death, bankruptcy, or disassociation of the manager, or on the occurrence of any other event that terminates the continued membership of the member in the company.

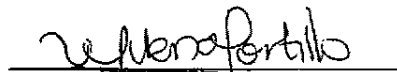

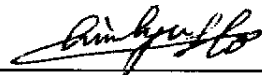
