#### ARTICLES OF ORGANIZATION

OF

#### ALTA REEF, LLC

Under the Florida Limited Liability Company Act

#### ARTICLE I NAME

The name of this limited liability company is ALTA REEF, LLC (hereinafter "the Company").

# ARTICLE II MAILING AND STREET ADDRESS

The mailing and street address of the principal office of the Company is 1712 N.W. 126th Drive, Coral Springs, FL 33071.

## ARTICLE III DURATION

## ARTICLE VII ADMISSION OF ADDITIONAL MEMBERS

Members of the Company have the right to admit new members only upon the written consent of all existing members, and the existing members shall determine the amount and nature of contributions by new members at the time new members are admitted. An assignee of a member's interest in the Company may become a member only if all existing members consent in writing.

## ARTICLE VIII INVOLUNTARY ASSIGNMENT OF MEMBER INTEREST
