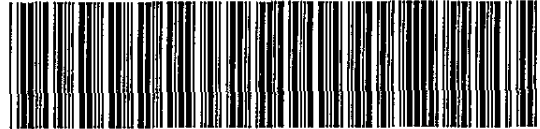

**ARTICLES OF ORGANIZATION FOR
FLORIDA PROFESSIONAL LIMITED COMPANY**

ARTICLE I - PURPOSE AND NAME:

For the specific purpose of providing psychological services, the name of the Professional Limited Company is:




