**ARTICLES OF ORGANIZATION
OF
SUNSOUTH HOSPITALITY ADVISORS, LLC**

The undersigned authorized representative executes these Articles of Organization to form a limited liability company under the Florida Limited Liability Company Act:

ARTICLE I. NAME

The name of the limited liability company is SunSouth Hospitality Advisors, LLC.

ARTICLE II. ADDRESS

ARTICLE III. REGISTERED AGENT AND OFFICE
