



### FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS MATTER came before this Court on June 16, 2010. The Wife was present without counsel and the Husband was present with counsel who offered evidence and testimony. The Court having confirmed residency, reviewed the pleadings, and having heard testimony of the Wife and Husband, it is thereupon

## ORDERED AND ADJUDGED:

- 1. <u>JURISDICTION</u>: This Court has jurisdiction over the parties and the subject matter of this action as the Husband testified that he has resided in the State of Florida for a period of six (6) months prior to the filing of this action.
- 2. MARRIAGE: The parties were married to each other on October 15, 1977.
- 3. <u>CHILDREN:</u> There are no children born of the parties' marriage and no other children are currently contemplated.
- 4. <u>DISSOLUTION OF MARRIAGE</u>: The marriage is irretrievably broken. Accordingly, the bonds of matrimony existing between the Wife, DEON HYMAN and the Husband, RONALD HYMAN, are hereby dissolved and the parties are hereby freed from the obligation thereof, except as otherwise provided in this Final Judgment.
- 5. TRANSCRIPT OF THE MARITAL SETTLEMENT AGREEMENT: The transcript of the Marital Settlement Agreement before the Hon. Richard L. Oftedal dated May 12, 2010, was introduced into evidence and attached hereto and marked as Exhibit "A", is in the best interests of the parties and is approved and incorporated in this judgment by reference and the parties are ordered to comply with it. Notwithstanding incorporation into the Judgment, the Marital Settlement

Agreement shall not be merged, but shall survive the Judgment and be binding on the parties, their heirs, administrators, legal representatives, assigns and estates.

- 6. **FORMER NAME**: The Wife's former name shall be restored and she shall hereinafter be known as **Deon Burton**.
- 7. JURISDICTION: The Court retains jurisdiction of this cause and the parties to enforce the terms of this Judgment and the Marital Settlement Agreement dated May 12, 2010 incorporated herein, as may from time to time become necessary, and to enter such further orders as it deems just and proper. The Court also retains jurisdiction over the execution and enforcement of any Qualified Domestic Relations Order (QDRO).
