This limited liability company shall be dissolved effective December 31, 2023.

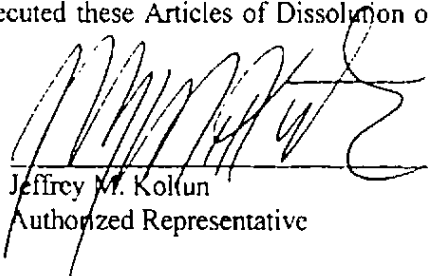
**ARTICLE III - APPROVAL OF DISSOLUTION**
