FOURTH AMENDMENT TO ARTICLES OF ORGANIZATION OF HIALEAH PARK INN, LLC

Pursuant to the provisions of Section 605, Florida Statutes, the undersigned, HIALEAH PARK INN, LLC, a Florida limited liability company (hereinafter the "Company"), hereby adopts the following Fourth Amendment to the Articles of Organization of the Company.

FIRST:

The name of the limited liability company is Hialeah Park Inn, LLC.

SECOND:

- (A) The date of filing of the Articles of Organization of 6650 West 20 Avenue, LLC, a Florida limited liability company was filed with the Florida Secretary of State on December 29, 2004.
- (B) Articles of Merger were filed with the Florida Secretary of State on December 30, 2004, in which Hialeah Park Inn Co., a Florida corporation, merged into 6650 West 20 Avenue, LLC, a Florida limited liability, with 6650 West 20 Avenue, LLC, being the surviving entity.

THIRD:

The Members of the Company previously adopted the following Amendments to its Articles of Organization of the Company as follows:

The Members of the Company, acting by and through its managing member, 6650 West 20 Avenue, LLC, a Florida limited liability company ("6650LLC"), acting by and through its sole

and managing member, InterAmerican Hotels Corp., a Florida corporation ("IAHC"), hereby further adopt the following Amendment (the "Fourth Amendment") to the Articles of Organization to amend ARTICLE VIIII of the Operating Agreement, as follows:

(A) All references to the name "GMAC Commercial Mortgage Bank, a Utah industrial bank ("GMAC")," in Article VIII, THIRD Section, Subsection (b) of the Third Amendment, entitled "Powers and Duties," are hereby deleted, and in its place and stead the name "Wells Fargo Bank, a National Association" is hereby inserted.

The foregoing Fourth Amendment to the Articles of Organization of the Company was duly and unanimously authorized, adopted and approved by its Members acting by and through 6650LLC, its Managing Member, acting by and through its sole and managing member, IAHC.
