
**ARTICLE XI

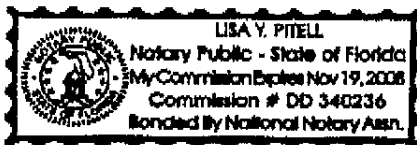
