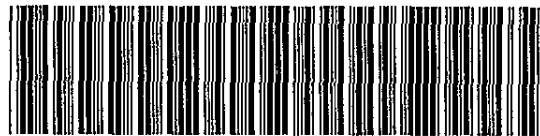

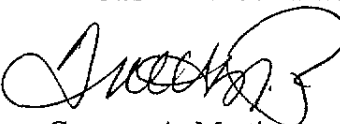

**ARTICLES OF ORGANIZATION
OF
HAN, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is Han, L.L.C. (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The initial mailing address and initial street address of the principal office of the Company shall be 7339A S.W. 45 Street, Miami, Florida 33155.

ARTICLE III. REGISTERED AGENT AND OFFICE

The name and street address of the initial registered agent of the Company in the State of Florida is Gregory A. Martin, Esq., Adorno & Yoss, P.A., 2525 Ponce de Leon Blvd., Suite 400, Miami, Florida 33134.

ARTICLE IV. DURATION

The Company shall commence its existence on the date that the Articles are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company amends its Operating Agreement to provide otherwise.

ARTICLE V. PROFITS AND LOSSES

Profits and losses shall be allocated to the member, as provided in the Operating Agreement, duly adopted and as amended from time to time by the member.

ARTICLE VI. RESTRICTIONS ON MEMBERSHIP

Additional members shall be admitted to the Company only with the written consent of the manager.

ARTICLE VII. MANAGEMENT

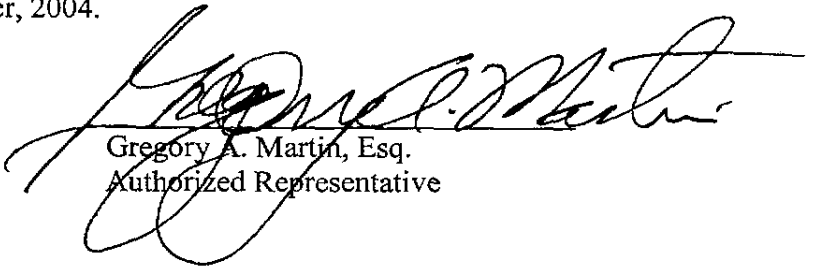
The Company shall be a manager-managed limited liability company and shall initially be managed by one manager in accordance with the Operating Agreement adopted by the member for the management of the business and affairs of the Company. The initial Manager of the Company shall be Ali Rezai and the Operating Agreement may contain any provisions for

the regulation and management of the business and operations of the Company, not inconsistent with Florida law or the Articles.

ARTICLE VIII. AMENDMENT

The Articles may be amended only by the written consent of the member.
