#### ARTICLES OF ORGANIZATION

OF

#### ZONE LOUNGE, L.L.C.

The undersigned person, acting as the organizer of **ZONE LOUNGE, L.L.C.**, (Tempany") under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, add the following Articles of Organization:

#### **ARTICLE I. NAME AND ADDRESS**

The name and mailing and principal address of the Company is: **ZONE LOUNGE, L.L.C.,** located at 123 E. Tarpon Avenue, Tarpon Springs, Florida 34689.

#### ARTICLE II. COMMENCEMENT AND DURATION OF EXISTENCE
