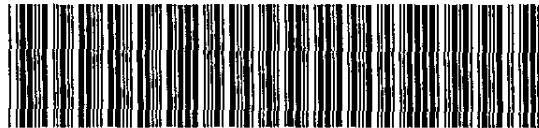



ARTICLES OF ORGANIZATION
OF
SOUTHWEST DENTAL LAB, LLC

ARTICLE I
NAME

The name of the limited liability company shall be Southwest Dental Lab, LLC (the "Company").


**CERTIFICATE OF DESIGNATION OF
