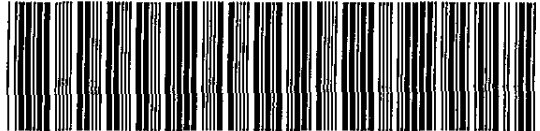

##### Admission of Additional Members






