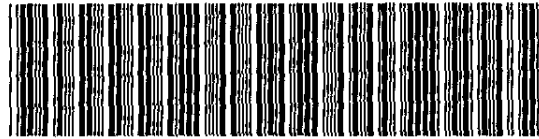

ARTICLE VIII

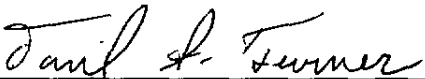
AMENDMENTS

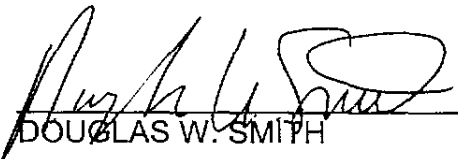
