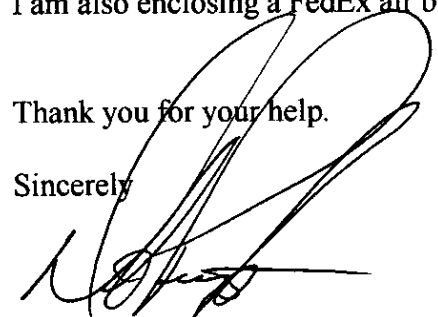
Dear Mr. Toner
