**ARTICLE II**

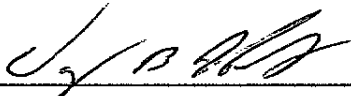
The corporation elected to dissolve by unanimous written consent of the directors and shareholders dated October 21, 1997.
