Pursuant to the provisions of Section 607.1003 and Section 607.1006 of the Florida General Corporation Act and the Professional Service Corporation and Limited Liability Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:


FIRST: The name of the Corporation is Fiveash & Associates, P.A.

SECOND: Section 1 of the Articles of Incorporation is deleted in its entirety and in its place and stead the following is inserted:
