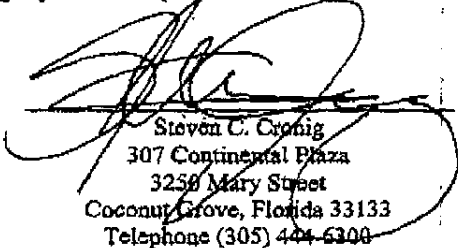
**First Amendment to Articles of Organization
