

**ARTICLES OF ORGANIZATION

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

Article I- Name

The name of the limited liability company is IRC Florida, LLC (the "Company").

Article II- Duration

The effective date and time of these Articles of Organization is January 1, 2005, at 12:01 a.m. The duration of the Company shall be perpetual, unless it is sooner dissolved in accordance with applicable law or its Operating Agreement.

Article III- Mailing Address and Street Address

The Company's initial mailing address is 7727B Holiday Drive, Sarasota, Florida 34231. The Company's initial street address is the same as the mailing address.

Article IV- Registered Agent and Office

The initial registered agent of the Company shall be David A. Yon. The street address of the initial registered agent is 301 South Bronough Street, Suite 200, Tallahassee, Florida 32301.

Article V- Additional Members

Additional members to the Company may be admitted, but only pursuant to the Company's Operating Agreement.

Article VI- Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may continue the business of the Company pursuant to the Company's Operating Agreement.

Article VII- Management of the Company

The Company shall be managed by its members in accordance with procedures set forth in its Operating Agreement.


Article VIII- Operating Agreement

The members shall have the power to adopt, alter, amend, or repeal an Operating Agreement containing provisions for the regulation and management of the affairs of the Company.

Article IX- Date of Existence of the Company

The existence of the Company shall commence on the date specified at Article II.




