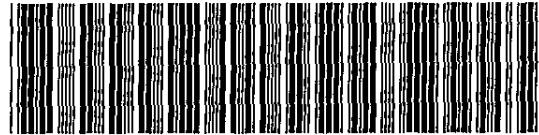


ARTICLE V
