**ARTICLES OF ORGANIZATION
FOR
CASA BELLA CAFE, LLC**

ARTICLE 1 – Name. The name of the limited liability company shall be Casa Bella Cafe, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 3170 Whisper Wind Drive, St. Cloud, Florida 34771.




