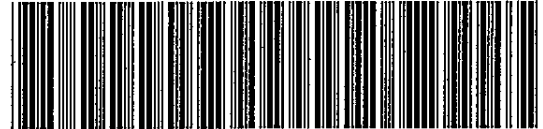

The following articles of amendment are submitted in accordance with Section 608.411, Florida Statutes.


1. The Articles of Organization for Lucamar, LLC (the "Company"), were filed on January 3, 2005 and assigned document number H05000000948.
