ARTICLES OF ORGANIZATION FOR THE LIMITED LIABILITY COMPANY OF JEFF PERKINS LAWN SERVICE, LLC

The undersigned, acting as the organizers of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), hereby form a Florida limited liability company (this "Company") pursuant to the Act and hereby set forth the following Articles of Organization (these "Articles"):

ARTICLE I Name

The name of this Company shall be JEFF PERKINS LAWN SERVICE, LLC

ARTICLE II Commencement Date and Duration

This Company shall commence upon properly filing these Articles of Organization, subsequent to subscription and acknowledgment in accordance with the provisions of Section 608.409(2) of the Act, and shall continue until dissolved by its members or managers in accordance with Section 608.441 of the Act or the provisions of these Articles. Subject to the foregoing, this Company shall be dissolved on the happening of any of the following events:

- 1. Withdrawal, retirement, death, resignation, bankruptcy, dissolution or expulsion of any member, unless the business of this Company is continued by the consent of all the remaining members;
 - 2. Unanimous written consent of all of the members; and
 - 3. Unanimous written consent of all of the managers.

ARTICLE III Purposes

This Company is created and formed for the primary purpose of engaging in all lawful businesses authorized for a Company pursuant to Section 608.403 of the Act, including without limitation, lawn and landscape maintenance services, and all such other activities incidental or useful to the foregoing.

ARTICLE IV Place of Business

The principal place of business of this Company shall be 2915 48th Street West, Bradenton, Florida 34209, and such other place or places as may be designated by the managers from time to time.

ARTICLE V Registered Agent and Office

The initial Registered Agent for this Company shall be JEFFREY L. PERKINS, and the address of the Registered Agent for service of process shall be 2915 48^{TH} Street West, Bradenton, Florida 34209.

ARTICLE VI Admission of Members

The initial members of this Company shall be JEFFREY L. PERKINS and C. JANELL PERKINS, and as set forth in the Operating Agreement and Regulations adopted by the members as set forth therein. The admission of additional members shall be accomplished only by the unanimous vote of the members, unless otherwise stated in the Operating Agreement and Regulations.

ARTICLE VII Continuation of Business

The members may, by unanimous written consent, continue the business of this Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of any member or upon the occurrence of any other event which terminates the continued membership of a member in this Company.

ARTICLE VIII Management of Business

The management of this Company shall be vested entirely in its manager. The name and address of its sole manager who shall serve until his successor is duly elected and are qualified as follows:

ARTICLE IX Powers

This Company shall have all of the powers and authorities set forth in Section 608 .404 of the Act.

ARTICLE X Property

- a. <u>Ownership</u>. All property originally paid or brought into, or transferred to, this Company as contributions to capital by the members, or subsequently acquired by purchase or otherwise on account of this Company shall be the property of this Company.
- b. <u>Title</u>. The title to, all property of the Company shall be held in the name of this Company.
- c. <u>Conveyances</u>. The manager(s) are hereby authorized to convey and obtain title to all real and personal property of whatever nature by the execution on behalf of this Company of any and all agreements, deeds, mortgages, trust agreements, indentures, leases, conveyance documents and all other certificates, instruments and documents as are necessary, reasonable or desirable to obtain title or convey title to any real or personal property whatsoever. Such execution shall be made by a majority of the managers if there be more than one. The signature and execution of such documents shall clearly set forth that the execution is on behalf of this Company and that the manager is signing on its behalf as manager. The following form of signature shall be used for obtaining or conveying title to any real or personal property:

ARTICLE XI Amendments

These Articles of Organization, except with respect to vested rights of the members, may be amended at any time either by vote by a majority in interest of its members; and such amendments shall be filed with the Florida Department of

State in accordance with the provision of Section 608.411 of the Act.

ARTICLE XII Regulations

The manager(s) are hereby authorized and directed to prepare and adopt an Operating Agreement and Regulations for the governing of the internal affairs of this Company containing such provisions as they consider necessary, reasonable or desirable, except that no provisions of such Operating Agreement and Regulations may conflict with the provisions of these Articles of Organization, unless otherwise permitted herein. The power to adopt, alter, amend or repeal the Operating Agreement and Regulations shall be set forth in the Operating Agreement and Regulations, except that the initial form shall be approved by all the members.

ARTICLE XIII Contracting Debts

No debt shall be contracted nor liability incurred by or on behalf of this Company except by its managers and no member is authorized or empowered to contract debts or incur liabilities on behalf of this Company unless such member is also a manager.


