The undersigned, for the purpose of Amending and Restating the Articles of Organization of 6159 KINGSLEY, LLC, under Section 608.411 of the Florida Limited Liability Company Act, F.S. Chapter 608 (the "Act"), hereby make, acknowledge, and file this Amended and Restated Articles of Organization. The original Articles of Organization for 6159 KINGSLEY, LLC was filed with the Florida Department of State on January 4, 2005. The Amended and Restated Articles of Organization shall read in full as follows:

**ARTICLE I - NAME**

The name of the limited liability company shall be 6159 KINGSLEY, LLC (the "Company").

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Company is 1915 Epping Forrest Way, South, Jacksonville, Florida 32217.

**ARTICLE III - DURATION**
