THE UNDERSIGNED MEMBER hereby adopts the following Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act.

ARTICLE I

Company Name and Principal Office

The name of the limited liability company shall be Almeria Investments, LLC (the "Company"), and the mailing and street address of the Company's principal office shall be located at 73 Almeria Street, St. Augustine, Florida 32084. However, the members shall have the power and authority to establish branch offices at any other place or places as they may so designate.

ARTICLE II

Management




