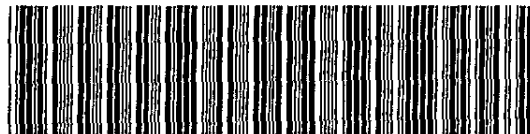

The members of the company shall contribute to the capital of the company the cash or property set forth in a written subscription agreement.


### ARTICLE X. ADDITIONAL CAPITAL CONTRIBUTIONS:
