ARTICLES OF ORGANIZATION OF J P'S ART WORLD AND DESIGNS, LLC

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I - Name:

The name of the limited liability company is J P 'S ART WORLD AND DESIGNS, LLC (the "Company").

ARTICLE II - Address:


