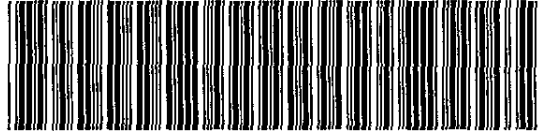

ARTICLE I: NAME

The name of this limited liability company shall be MLG Pizza Holdings, LLC (the "Company").

ARTICLE II: MAILING AND STREET ADDRESS

The Company's principal office location is 600 N.W. 75th Street, Suite D, Gainesville, Florida 32607, and its mailing address is 3807 N.W. 75th Terrace, Gainesville, Florida 32606.

ARTICLE III: INITIAL REGISTERED OFFICE AND AGENT
