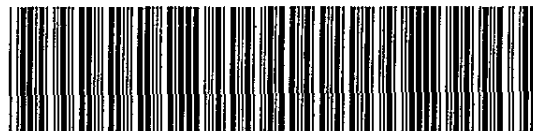



**ARTICLES OF ORGANIZATION OF
JONES & MCKOWN, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida sets forth the following:

ARTICLE I: NAME

The Name of the Limited Liability Company is: Jones & McKown, LLC

ARTICLE II: ADDRESS

The Mailing Address of the Principal Office is: 4712 West Laurel Road, Tampa, Florida 33629.

The Street Address of the Principal Office is the same.

ARTICLE III: DURATION

The duration for the Limited Liability Company shall be perpetual.

ARTICLE IV: MANAGEMENT

The Limited Liability Company is to be managed by one or more managers and is, therefore, a manager managed company.

ARTICLE V: ADMISSION OF ADDITIONAL MEMBERS
