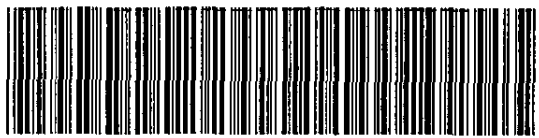

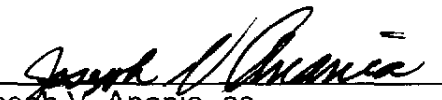
**ARTICLE VIII – OPERATING AGREEMENT**
