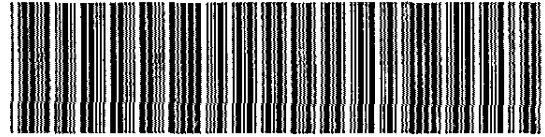

# **ARTICLES OF ORGANIZATION**

**of**

## **THE COMMERCE LAW GROUP, a professional limited company**

### **ARTICLE I: NAME**

This Company shall have perpetual existence.


#### **ARTICLE V: PURPOSE AND POWERS**


