**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
NORTH BAYSHORE LAND HOLDINGS, LLC**

Pursuant to the provisions of Section 608.411, Florida Statutes, the undersigned Florida limited liability company adopts the following articles of amendment to its Articles of Organization.

- FIRST :** The name of the limited liability company is NORTH BAYSHORE LAND HOLDINGS, LLC.
- SECOND:** The date of filing of the Articles of Organization was January 5, 2005.
- THIRD:** The Articles of Organization are hereby amended by deleting Article III in its entirety and substituting the following in lieu thereof:

ARTICLE III - Purpose:

The sole purpose of the Limited Liability Company is to acquire, develop, hold, improve, subdivide, maintain, operate, and sell the parcels of land and/or finished lots located on the real property more fully described in the Limited Liability Company's Operating Agreement dated January 6, 2005, as amended (the "Land") (the Land, together with all improvements thereon and appurtenances thereto at any time during the term hereof, are sometimes collectively referred to as the "Project" or "Projects"), and further to engage in any other business or activity that may be incidental, proper, advisable or convenient to accomplish the foregoing purpose (including, without limitation, obtaining financing therefor) and that is not forbidden by the law of the jurisdiction in which the Limited Liability Company engages in that business. It is contemplated that the acquisition of the Land and development of such Project will be made through a combination of bank or other institution financing and through capital contributions by the members to the Limited Liability Company.




