The name of the limited liability company shall be 4350 PGA, LLC.

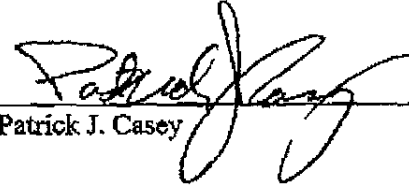
