ARTICLES OF ORGANIZATION

OF

HOSS CAPITAL, LLC

MIS JAH - 3 PH 1: 3' The undersigned hereby certifies that he is the authorized representative of the initial member[s] who have associated themselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. He further declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE 1 NAME AND BUSINESS ADDRESS

5.
